# **Background**

Automatic voter registration is a policy that modernizes the voter registration process by automatically registering eligible voters through their interactions with state agencies, most commonly when people apply for or renew their driver's licenses. Automatic voter registration helps ensure that every eligible voter has access to vote and strengthens the security and accuracy of our election systems.

Our scoring distinguishes between Secure AVR and Partial AVR. In Secure AVR systems—sometimes referred to as "back-end AVR" — designated agencies such as state DMVs systematically send information from relevant transactions to state election authorities. Once the voter's eligibility is confirmed, the voter is then automatically registered (or registered in pending status) before being given an opportunity to opt-out at a later time, usually through the mail. Secure AVR systems are more efficient and effective at registering eligible voters, keeping registration records accurate, and registering only U.S. citizens to vote. In Partial AVR systems—sometimes called "front-end AVR" — the voter is given an opportunity to opt-out of being registered at the time of the relevant agency transaction. Partial AVR is an improvement over traditional registration systems but is relatively less efficient than Secure AVR.

### **Scoring**

- If state has secure automatic voter registration (also referred to as back-end) automatic voter registration, +1 point
- If state has partial automatic voter registration (also referred to as front-end), +1/2 point
- If state does not have automatic voter registration, 0 points

# Chronology

- January 2016: Oregon becomes the first state to implement AVR
- 2016: Georgia implements AVR
- 2017: Alaska, Colorado and Vermont implement AVR
- 2018: California, D.C., Illinois, New Jersey and Rhode Island implement AVR
- 2019: Maryland, Michigan and Washington implement AVR
- 2020: Connecticut, Massachusetts, New Mexico, Nevada and Virginia implement AVR
- 2021: Hawaii and West Virginia implement AVR
- 2022: Maine implements AVR
- 2023: Delaware and New York in process of implementing AVR. Minnesota passes legislation to enact AVR. Nevada and Washington pass legislation to update AVR systems to secure (back-end). Pennsylvania implements partial (front-end) AVR administratively.



# **State-by-State Sources and More Detail**

#### Alabama (0)

State does not have automatic voter registration.

### Alaska (1)

- State has secure (back-end) automatic voter registration.
- In 2016, Alaska voters approved <u>Ballot Measure 1</u>. This law automatically registers eligible applicants to vote or updates voter registration information of voters who are currently registered to vote using the information provided when applying for a Permanent Fund Dividend (PFD) unless the applicant opts-out. The law was implemented in 2017. (AS 15.07.070)

# Arizona (0)

State does not have automatic voter registration.

#### Arkansas (0)

State does not have automatic voter registration.

### California (1/2)

- State has partial (front-end) automatic voter registration.
- California <u>AB 1461</u> established automatic voter registration in the state in 2015. The law
  was implemented in 2018. The Department of Motor Vehicles provides information
  resulting from interactions with their agency to the Secretary of State; these records
  constitute a completed affidavit of registration unless the voter affirmatively declines to
  register, or is ineligible. (Ca. Elec. Code § 2263-2265)

## Colorado (1)

- State has secure (back-end) automatic voter registration.
- Colorado implemented automatic voter registration through an administrative process in 2017 and was initially conducted through the DMV. Additional agencies have since been incorporated into the process.

### Connecticut (1/2)

- State has partial (front-end) automatic voter registration.
- Connecticut enacted automatic voter registration in 2016 through an <u>agreement</u> between the Secretary of State and the DMV. It was implemented in 2020.

### Delaware (1)

• State has secure (back-end) automatic voter registration (DE SB 5 (2021)).



# D.C. (1/2)

- State has partial (front-end) automatic voter registration.
- D.C. enacted automatic voter registration in 2016 (<u>B21-0194</u>). The law was implemented in 2018. (D.C. Official Code § 1-1001.07)

### Florida (0)

• State does not have automatic voter registration.

### Georgia (1/2)

- State has partial (front-end) automatic voter registration.
- Georgia implemented automatic voter registration administratively through the Department of Driver Services and the Office of the Attorney General in 2016.

# Hawaii (1/2)

- State has partial (front-end) automatic voter registration (<u>HI SB 159</u> (2021)). Idaho (0)
  - State does not have automatic voter registration.

# Illinois (1/2)

- State has partial (front-end) automatic voter registration.
- Illinois enacted automatic voter registration in 2017 (<u>SB 1933</u>). The law was implemented over the period of 2017-2019. (10 ILCS 5/1A-16.1)

### Indiana (0)

- State does not have automatic voter registration lowa (0)
  - State does not have automatic voter registration.

- Maryland enacted automatic voter registration in 2018 (<u>SB 1048</u>). The law was implemented in 2019 (Md. Code, EL § 3-203).

### Massachusetts (1)

- State has secure (back-end) automatic voter registration.
- Massachusetts enacted automatic voter registration in 2018 (<u>HB 4834</u>). The law was implemented in 2020 (Mass. Gen. Laws ch. 51, § 42G).

# Michigan (1/2)

- State has partial (front-end) automatic voter registration.
- Michigan voters approved automatic voter registration in 2018 as part of <u>Proposal 3</u>.
   The law was implemented in 2019 (MCL 168.493a)

### Minnesota (1)

- State has secure (back-end) automatic voter registration.
- Minnesota enacted automatic voter registration in 2023 (MN HB 3 (2023)).

# Mississippi (0)

• State does not have automatic voter registration.

### Missouri (0)

# Nevada (1)

- State has secure (back-end) automatic voter registration.

   The law was implemented in 2020 (NRS 293.5732)

# New Jersey (1/2)

- State has partial (front-end) automatic voter registration.
- New Jersey enacted automatic voter registration in 2018 (<u>AB 2014</u>). The law was implemented in 2018 (N.J.S. § 19:31-6.14).

### New Mexico (1/2)

- State has partial (front-end) automatic voter registration.
- New Mexico implemented automatic voter registration administratively in 2018.

### New York (1/2)

- State has partial (front-end) automatic voter registration.
- New York enacted automatic voter registration in 2020 (<u>SB 8806</u>). The law was implemented beginning in 2023.

# North Carolina (0)

• State does not have automatic voter registration.

# North Dakota (0)

• Does not require voter registration.

### Ohio (0)

State does not have automatic voter registration.

# Oklahoma (0)

• State does not have automatic voter registration.

# Oregon (1)

- State has secure (back-end) automatic voter registration.
- Oregon enacted automatic voter registration in 2015 (<u>HB 2177</u>). The law was implemented in 2016 (ORS 247.017).

# Pennsylvania (1/2)

- State has partial (front-end) automatic voter registration.
- Pennsylvania implemented automatic voter registration administratively in 2023.

### Rhode Island (1/2)

- State has partial (front-end) automatic voter registration.
- Rhode Island enacted automatic voter registration in 2017 (<u>HB 5702</u>). The law was implemented in 2018 (R.I. Gen. Laws § 17-9.1-7).

### South Carolina (0)

State does not have automatic voter registration.

State does not have automatic voter registration.

#### Tennessee (0)

### Vermont (1/2)

- State has partial (front-end) automatic voter registration.
- Vermont enacted automatic voter registration in 2016 (<u>HB 458</u>). The law was implemented in 2017 (17 V.S.A. § 2145a).

### Virginia (1/2)

- State has partial (front-end) automatic voter registration.
- Virginia enacted automatic voter registration in 2020 (HB 235).

### Washington (1)

- State has secure (back-end) automatic voter registration.
- Washington first enacted front-end automatic voter registration in 2018 (<u>HB 2595</u>). The law was implemented in 2019 (RCW 29A.08.355).
- Washington updated their AVR law to implement a back-end system in 2023 (SB 5112).

# West Virginia (1/2)

- State has partial (front-end) automatic voter registration.
- West Virginia enacted automatic voter registration in 2016 (<u>HB 4013</u>). The law is currently being implemented.
